INTRODUCTION

These guidelines describe the visual elements that represent the logos and identity of the Metropolitan Knoxville Airport Authority. This includes proper names, logos, colors, graphics and appropriate usage.

The consistent and controlled use of all MKAA external images and logos are important in conveying a professional, unified image of our organization to the public and our business partners. Logos appear on all MKAA visual messages, including signage, advertisements, stationary, vehicles, apparel, etc.

The full MKAA name and logo should be featured in all uses unless it is neither feasible nor preferred in some limited space applications such as embroidery. In those unique situations, the primary icon must be the visual element and you must submit the proposed, altered design to the Public Relations Department for consideration. For tracking purposes only, please submit a copy of the design and/or purchase order to the Public Relations Department when using the primary icon or logo.

Our brand and logos are valuable MKAA assets. Each MKAA employee is responsible for protecting the organization's brand assets by preventing incorrect or unauthorized use of all logo elements. All logos are the intellectual property of the Metropolitan Knoxville Airport Authority and may not be used by any MKAA employee or outside organization without the formal approval of Metropolitan Knoxville Airport Authority management.

ELEMENTS

The MKAA logo is composed of two elements: the circular graphic (which may be used as a stand-alone logo in certain applications) and the MKAA logotype. It is preferred that all logos appear on a white background except for special circumstances where a white background is not an option.

The circular graphic is composed of a green and a blue section, divided by a white line and overlaid with a white stylized aircraft. The green color is **PMS #355**, and the blue color is **Process Blue**. No other colors may be used in the MKAA primary logo.

It is permissible for the logo to appear in black and gray on a white background. A single-color version of the logo may appear in white only on a dark or black background.

The logotype is done in black **Adobe Jenson Pro Display** font separated by black lines and may appear either to the right or below the circular graphic. The logo font shall not be interchanged with a different logo font. In the event that the black lines are not feasible, please use logo #3 in the Logo Chart provided in this guideline on page 15.

All MKAA employees are required to adhere to these branding and identity standards.

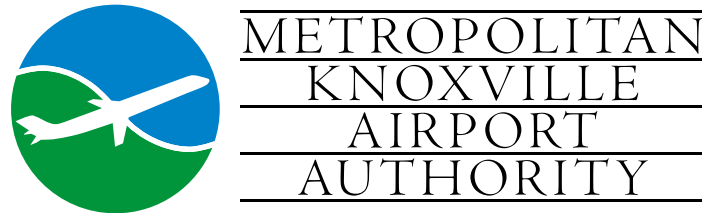
MKAA PRIMARY LOGO (Logo #1 on the Logo Chart)

LOGO EXEMPTION

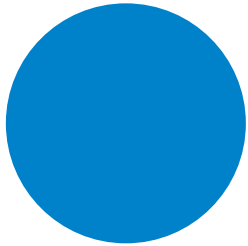

There are two approved logos for use when you wish to specifically identify as McGhee Tyson Airport (TYS). These logos should be used in all circumstances unless the logo design requires adjustment due to the material being used or there are restrictive limitations set by a third party (ex. Sponsorship banner where multiple logos are grouped together in a limited space.). Each of the two logo options has its own font. They are not interchangeable.

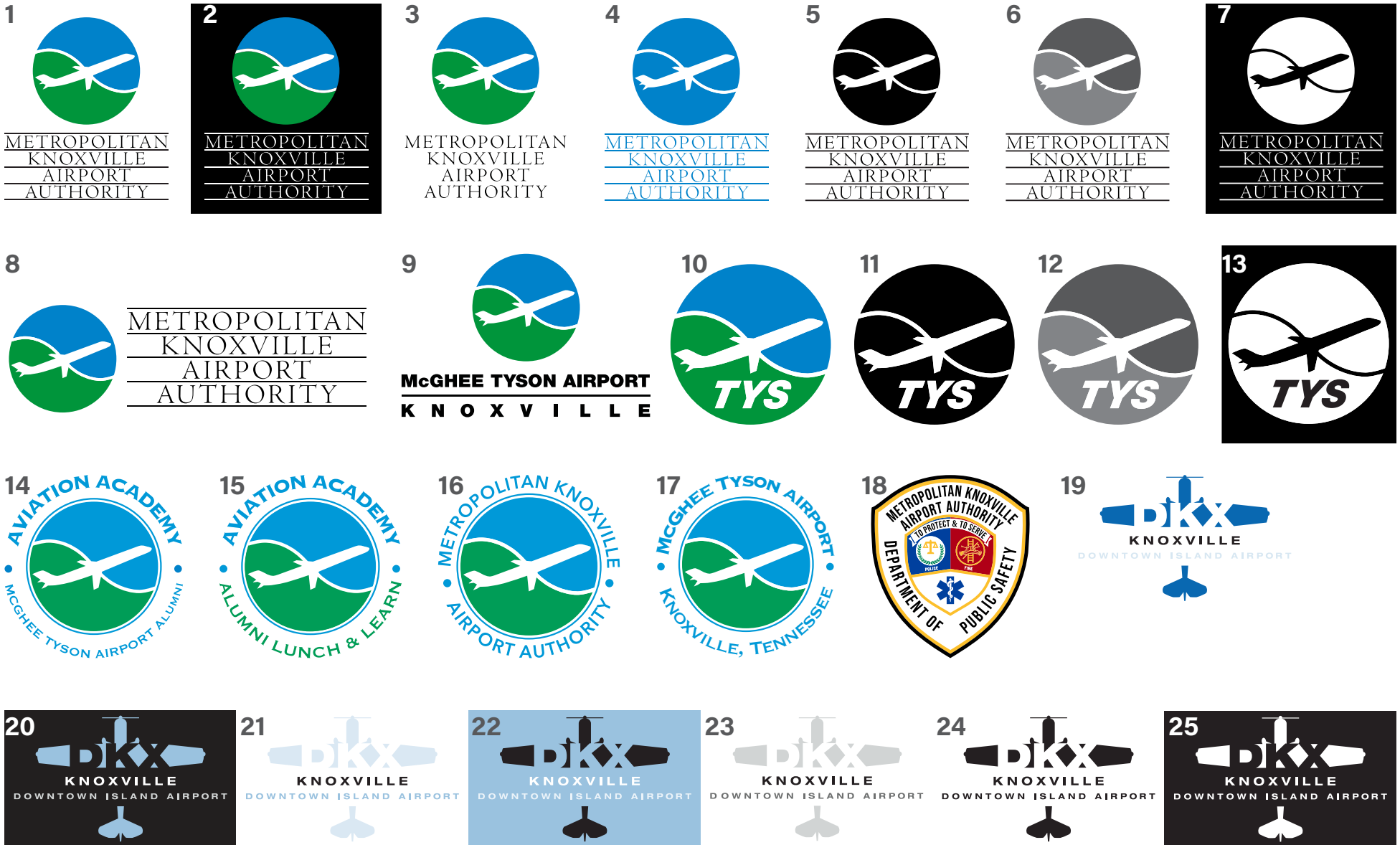
